Definitions

Commercial Feed – materials distributed for use as feed or for mixing in feed, for animals other than humans.

Manufacture - to process, grind, mix, package, or blend feed for distribution.

Distribute - to offer for sale, hold for sale, sell, barter, or otherwise supply commercial feed.

Customer-formula feed – commercial feed which consists of a mixture of commercial feeds, a mixture of commercial feeds and other ingredients, or a mixture of other ingredients, each batch of which is mixed according to the specific instructions of the final purchaser.

Important Information

- All product labels **MUST** be approved by the Department prior to their distribution in Michigan. Include all new/revised labels with your application.
- Any incomplete applications will be returned and no license will be issued.
