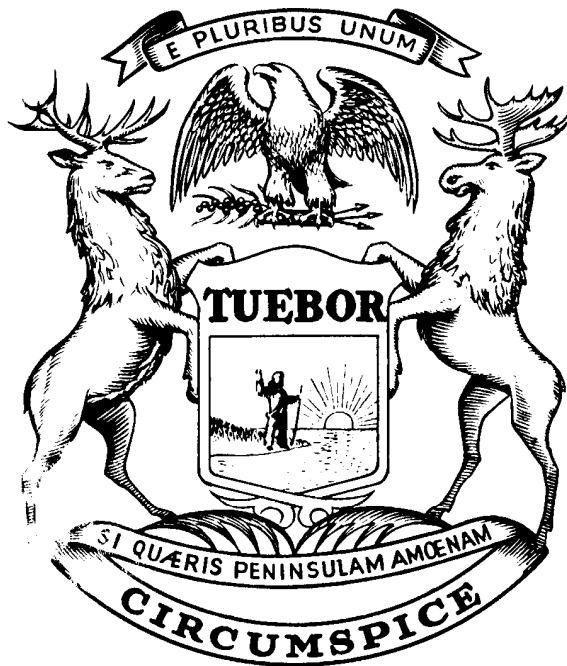

Public Act No. 74 of 1997 requires a person who holds a casino interest to file a registration form with the Secretary of State within 5 days after obtaining the casino interest. Attorney General Opinion, No. 7053 (May 3, 2000), removed the registration requirement for the spouses and children of persons holding a casino interest.*

**The following persons are required to file the Casino Interest Registration Form
(CASINO INTEREST DESCRIPTION CODE LIST)**

* Persons meeting description codes 2, 3, 5, 6, 8, 9, 11, 12, 14, 15, 17, 18, 20, 21, 23, 24, 26, 27, 29, and 30 are no longer required to register.
